Imotion is a German engineering company based in Hennigsdorf, close to Berlin. The company currently employs 16 professionals. Citec aims at having fully operational personnel in Germany as of September 1. Holger Wülfken, currently the Managing Director of Imotion, has been appointed Managing Director of Citec's operations in Germany. The new company will be marketed as Citec Germany and registered as Citec Engineering & Information GmbH.
