## **CITEC GROUP ISSUES A 4-YEAR SEK 290 MILLION SENIOR SECURED BOND AND AIMS TO CONTINUE PROFITABLE GROWTH**

**A new parent company of Citec Group issues a senior secured bond amounting to SEK 290 million. The group aims to continue profitable growth with medium-term target revenues of EUR 100 million and a minimum EBITDA margin of 10%.**

International engineering services company Citec carries out a transaction in which a new parent company of Citec Group Oy Ab, Sentiec Oy, issues a 4-year senior secured bond amounting to SEK 290 million with a total frame amount of SEK 500 million. The group aims for profitable growth and targets revenues of EUR 100 million with a minimum EBITDA margin of 10% in medium-term.

“Sentica has been working with the company since 2011, when Citec was formed by combining Citec Engineering and Citec Information. Citec has developed well under the new management and we foresee a lot of interesting opportunities for the company in the coming years.
